

Mid Florida Community Services experienced a major shift in 2024. In my last letter, you may recall me mentioning an organizational rebirth. Well...it happened! In May 2024, Mid Florida Community Services transitioned to the name **You Thrive Florida**, which bore a new mission, vision, and logo.

This new brand is fresh, modernized, and better represents who we are and what we want to achieve. Furthermore, it will help alleviate confusion with other similar like brands throughout our service region.

You Thrive Florida is a brand that will elicit better recognition from our customers, partners, and communities. It also positions us as a leader in the nonprofit sector in providing life changing services and opportunities to individuals and families, in an effort to improve their ability to thrive.

The key to building thriving communities is to target the individuals living within them. Collectively, with our community partners, we possess the power to influence positive change that benefits all community members.

One of the other major highlights in 2024 is the approval of a \$2.5M appropriation request from the Florida Legislature to build a state-of-the-art **Children's Advocacy Center of Hernando County**. We are incredibly thankful to Senator Blaise Ingoglia for spearheading this request and the rest of the Florida legislative members for their support.

Additionally, we completed our three-year **Comprehensive Community Assessment,** which is a robust tool to identify community needs and serves as the foundation for strategic planning.

> Strengthening services within our current programs and identifying expansion opportunities to support other needs in the community assessment will also be a priority.

As always, I would like to thank all You Thrive Florida staff, Board of Directors, and Head Start/Early Head Start Policy Council members for their ongoing commitment to children, families, and communities served. Our Programs

The Community Assistance Program

assists low-income individuals/families by assisting with education, training, testing, energy payments, rent/mortgage assistance, and reducing energy costs by improving energy efficiency in the home. This assistance is through our: Community Services Block Grant (CSBG), Family Self-Sufficiency Program, Emergency Services, Employment Support, Low-Income Home Emergency Assistance Program (LIHEAP) and Weatherization Assistance Program.

House to Home is a

homeownership program that seeks applicants who have a demonstrated need for housing and have the financial ability to own a home, even if they would not qualify for a traditional mortgage.

The Children's Advocacy Center (CAC)

coordinates the investigation, prosecution, and healing services for child abuse cases in Hernando County. Each year, the CAC serves more than 800 children and their nonoffending family members who were: sexually abused, physically abused, victims of human trafficking, witnessed a violent crime, exposed to substance abuse, exposed to pornography and child pornography, and children who were neglected. **Senior Services** programs offer a wide array of services designed to support aging seniors in their efforts to live independently in their own homes, improving their ability to function and avoiding costly placement in long term care facilities.

You Thrive **Paratransit** is Hernando County's designated Community Transportation Coordinator (CTC), providing safe, efficient, cost-effective, and quality transportation services for transportation-disadvantaged citizens of Hernando County.

Our Early Learning Programs,

including Preschool Head Start, Early Head Start, School Readiness, and VPK, go beyond typical childcare to promote comprehensive development, focusing on school readiness and social skills.

Our programs strongly emphasize male engagement and fatherhood, underscoring the crucial role fathers have in child development. We focus on assisting homeless families and children with IEPs, aiming to empower families towards selfsufficiency and goal achievement.




Program Impact

Community Assistance

- 2,823 households received energy assistance
- **327** households received emergency assistance for rent/mortgage, car repairs, temporary shelter, tuition assistance
- 26 households received water/wastewater assistance
- **\$372+** average annual cost savings per household through weatherization and upgrades
- \$127,596 cumulative cost savings

- **Partners**: Florida Department of Transportation, Transportation Disadvantaged




Children's Advocacy Center of Hernando County

Senior Services


- 4,575 telephone reassurance calls

You Thrive partnered with Florida Council on Aging to distribute File for Life, with support from Duke Energy. The hurricane prep project encourages people to compile all of their information in the file that they or a caregiver can grab during an emergency.

Early Learning

A family with two young children at Oak Ridge Center lost their home, and ended up in Hope Place. As a shift manager at McDonald's, the mother hired other mothers at Hope Place to work at McDonald's, and found housing through the Housing Authority. She was pregnant and welcomed a healthy baby boy in October 2023.

Community Assistance

As a full-time nursing student, my income was strained because I wasn't able to work many hours. That's where You Thrive came in by assisting me with tuition, uniforms, books, nursing supplies, testing fees, and outside expenses.




